Subject : Finalisation of Scheme for Assam Sanskrit College.

Sir,

I am directed to invite your attention to the fact that scheme for establishment of Assam Sanskrit College should be implemented as a State Plan Scheme for as a centrally sponsored scheme is being examined by the Govt. to whom the matter has been referred to by this office on 24.4.70. The decision of which is still awaited on this. If the scheme is agreed to be implemented from the centrally sponsored sector then the amount required will be available out of the Plan ceiling and in that case we may aim at for implementation of a bigger scheme, but in case the scheme is to be implemented from the State Plan sector then we will have to limit our expenditure within our Plan allocation. In that case we cannot expect to implement a scheme beyond Rs. 6 to 8 lakhs and the scheme should accordingly be prepared within that limit.

Pending Govt. decision on the matter you are therefore requested to prepare 2 sets of schemes of which one will fit in for implementation from the State Plan sector and the other to be fit in for implementation from the Central Sector.

The schemes received from you and from the Secy. Assam Sanskrit Board, Gauhati are sent herewith (in original) for placing before the Governing Body of the College for finalisation. The G.B. may also constitute a small committee that should decide-

1. Courses to be introduced in the college in a phased manner.
2. Manner of recruitment of staff and qualification required.
3. Value and number of stipends.
4. Accommodation- temporary and final.

I am, therefore, to request you kindly to convene a meeting of the G.B. early and place the matter before the G.B. for decision.
